Application Procedures

To be considered for one of two **\$500** AAFCS-Texas Affiliate Student Scholarship, you must do the following:

- (1) Complete a AAFCS-Texas Affiliate Student Scholarship Application form. Be sure to neatly type or word process all of the information and complete all sections of the form.
- (2) Obtain an official transcript(s) of all college work.
- (3) Mail the completed application form and the official transcript(s) postmarked *no later* than December 1 to

- (4) Request a letter of recommendation from the dean of your college or school *or* from the chair of your department to be sent directly by the above address *no later* than December 1.

Necessary Qualifications

To qualify for one of two **\$500** AAFCS-Texas Affiliate Student Scholarship, you must fulfill the following:

- (1) Be enrolled at a college or university in Texas.
- (2) Be majoring in a program in a college, school, or department of family and consumer sciences *or* a program in one of the knowledge-based areas of family and consumer sciences.
- (3) Be classified as a junior.
- (4) Be a current member of the AAFCS-Texas Affiliate Student Section.

Basis of Selection

Award decisions will be based on good academic achievement, a positive letter of recommendation, solid character, appropriate professional goals, appropriate preprofessional involvement, and financial need.

Notification and Presentation of Awards

Award recipients will be notified by the AAFCS-Texas Affiliate President. Scholarship recipients will be recognized at the Awards Banquet to be held during the 2010 AAFCS-Texas Affiliate Annual Meeting. Scholarship funds will be available for use during Fall.
